2. What kind of information do we collect?

We collect personal data about you whenever you use our services. We will only use your personal data when the law allows us to. Most commonly, we will use your personal data only:

5. Use of the Passively Collected Data

7. Disclosure of collected information

We do not sell or rent email addresses and other personal information that we collect directly through the P.G.T. Tour Group(Private Greece Tours) Website. Please be aware, however, that any information that you voluntarily choose to display on any publicly available portion of the P.G.T. Tour Group(Private Greece Tours) Website or on any Service, becomes publicly available and may be collected and used by us or others without restriction. We share your information, including personal information, as follows:

For arranging your requested service

When you make travel arrangements with P.G.T. Tour Group (Private Greece Tours) and you provide information about yourself, we use this information to complete your order (i.e. to complete hotel or other reservations), fulfill any customer service requests, and provide promotional or trip related information via email or direct mail. We do not share this information with outside parties except to the extent necessary to complete your order and fulfill your travel arrangements. Such other parties may include, but are not limited to, appropriate travel suppliers, credit card merchant services etc. These service providers will disclose information about your traveler profile to hotel, airline, cruise and other travel suppliers whose products you have purchased.

Although P.G.T. Tour Group(Private Greece Tours) attempts to select travel suppliers that are reputable companies, we have not placed limitations on these suppliers from using or disclosing your information privacy practices of any travel suppliers whose products you purchase through P.G.T. Tour Group(Private Greece Tours). In addition, these travel suppliers may also contact you as necessary to obtain additional information about your confirmed reservation.

Legal requirements

We may disclose personal information if we have a good-faith belief that doing so is required by a judicial or administrative order or otherwise required by law. Additionally, we may disclose personal information where we, in good faith, deem it appropriate or necessary to prevent violation of our agreements; take precautions against liability; protect the rights, property, or safety of P.G.T. Tour Group (Private Greece Tours) Website, any individual, or the infrastructure; protect ourselves and our Services from fraudulent, abusive, or unlawful uses; investigate and defend ourselves against third-party claims or allegations; or assist government enforcement agencies.
